**Dear Civilekonom student,**

Congratulations on securing a place in **Civilekonomprogrammet – Nationalekonomi** at JIBS, a double-accredited business school with a strong international profile. I would like to take this opportunity to welcome you to the programme and provide you with some initial information about your first two courses. I am very pleased that you have chosen this programme, and I can assure you that my colleagues and I will do our utmost to provide you with an excellent education and experience here at JIBS.

The programme you are enrolled in will lead to a professional degree as a *Civilekonom* and is designed to develop your ability to understand and analyse various types of socio-economic problems within an international and global economic context. You will learn to use economic theory to analyse and evaluate economic problems and understand their underlying factors. The ability to analyse problems systematically is fundamental to modern economics and is a core aspect of the entire programme. The primary focus of the programme is economics, in which you will earn 120 credits.

Additionally, you will gain a strong foundation in mathematics, statistics, and econometrics, with 37.5 credits in these subjects. This will equip you with the necessary skills and tools to process and analyse data, including for your thesis (*Examensarbete – nationalekonomi*) in your final semester. These skills are increasingly sought after in the job market upon graduation. The programme also includes 30 credits in business administration, covering various aspects such as leadership, entrepreneurship, accounting, and finance, providing insights into the business side of your education. It also includes business law (*Handelsrättslig översiktskurs*), in which you will earn 15 credits.

Furthermore, there is a full semester dedicated to studying abroad at one of our partner universities worldwide, during which you are free to choose 30 credits in topics that interest you. In addition, you will have a further 7.5 credits of electives in the sixth semester. For the electives, at least 7.5 credits must be completed as an internship or equivalent in either business administration or economics. The electives offer a unique opportunity to either broaden or specialise your knowledge in a subject of your choice, while also providing valuable practical experience.

The programme starts on Monday, 25 August, with a formal roll call at JIBS. The following are the first two courses you will take.

**Introduction to Economic Thought**

This course introduces you to the origins of economic theories and their development, as well as their interconnections with other fields such as political science and philosophy. It will also enhance your understanding of how economic thought has influenced societal development and the role of institutions.

The course will cover the ideas and theories of classical economists, including Adam Smith, David Ricardo, Karl Marx, John Maynard Keynes, and Joseph Schumpeter. It will also explore the contributions of Nobel Memorial Prize laureates in Economics.

### **Introduction to Mathematical Methods for Economic Analysis**

This course introduces key mathematical tools used in economic analysis, equipping students with foundational skills in equations, functions, calculus, optimisation, and probability theory. These methods form the language through which modern economics and business studies communicate and advance knowledge.
